HEALTH COMMITTEE UPDATES

New Vaccine Recommendations

I know the vaccine controversy rages on the dog boards and among our members. I am not going there. It is of interest to note that when polio was eradicated and we quit vaccinating children for polio regularly there was a subsequent outbreak in young adults years later. Now with the development of the new high titer vaccines, the experts told us we could safely quit vaccinating at 12 weeks. They were wrong and have revised their recommendations as of January 2007.

AAHA Task Force Amends Guidelines for Puppy Vaccines

Responding to a number of reports of Parvovirus in puppies vaccinated for the disease, AAHA task force members have reassessed the 2006 AAHA Canine Vaccine Guidelines released in February 2006 and amended the guidelines as follows.

Instead of recommending that Parvovirus and Distemper vaccines end at 12 weeks of age, veterinary professionals now suggest extending the series to 14 or 16 weeks of age to ensure that maternal antibodies do not interfere with the vaccines.

The revised guidelines suggest that a minimum of three doses of vaccine are given against Distemper, Adenovirus -2, and Parvovirus between six and 16 weeks of age administered at three to four week intervals.

Additionally, it is recommended that all puppies receive a booster one year after completion of the initial puppy series.

"It is theorized that high levels of maternal antibodies are interfering with complete immunization at 12 weeks of age," said Michael Paul, DVM, task force chairman. The revised protocol suggests vaccination at six weeks, 10 weeks, and again at 14 weeks or vaccination at eight weeks, 12 weeks, and again at 16 weeks.

Microchips and Cancer

I have heard lots of discussions relating to our continuing to microchip dogs. I have never seen a microchip related sarcoma in a dog, cat, horse or ostrich. Of course the rumor mill is more active that the facts. Below are the actual facts I could find from VIN and other sources.

Information provided by Avid Identification Systems

"I'm a little late on this discussion but need to make you aware there are some recent references to several foreign articles linking microchips and neoplasia. There are millions of American horses, dogs, cats and other animals microchipped with no problems. Dr. Macy of Colorado Veterinary School has research and opinion that, other than possible link of surface contaminant or impaled hair, microchips are not problem. Rao and Edmondson from National Institute of Environmental Sciences did a 1990 study with 70 animals and found no microchip-cancer link. JAVMA, Nov 1, 2003, pp 1316-19 has horse study with no problems noted."

For those of you that do not know or remember, Dr Macy is one of the pioneers in vaccine related fibrosarcoma research. He is also one of the leading proponents of extended use vaccines.

Here is the link to article quoting some foreign studies that noted microchips causing cancer in mice and rats used for other studies. It could be argued that these mice and rats were genetically engineered to be more susceptible to cancer and/or the microchip is relatively a much larger mass than in a dog or horse.

Here is an abstract of the article causing the big fuss. As near as I can tell it is the ONLY report of a microchip causing cancer in a dog.

Abstract

A 9-year-old, male French Bulldog was examined for a subcutaneous mass located at the site of a microchip implant. Cytologic examination of the mass was suggestive of a malignant mesenchymal neoplasm. Histologically, the mass was confirmed as a high-grade infiltrative fibrosarcoma, with multifocal necrosis and peripheral lymphoid aggregates. By immunohistochemistry, the sample was investigated for vimentin, smooth-muscle actin (SMA), CD3, CD79alpha, and CD18. All the neoplastic cells were positive for vimentin. Scattered cells at the periphery of the lesion were also positive for SMA, highlighting a myofibroblastic phenotype. The lymphoid cells were positive for CD18 and CD3. No aluminum deposits were detected by the aurintricarboxylic acid method. A diagnosis of fibrosarcoma morphologically similar to feline postinjection sarcomas was made. Fibrosarcomas at the site of injections have been reported in dogs and ferrets. Furthermore, neoplastic growth at the site of microchip implant in dog and laboratory rodents has been described.


At this time my opinion (not that of the PHCA necessarily) is that the risk of losing a Pharaoh Hound from running loose, getting away at a coursing event, etc., is far greater than any danger from a microchip. I also admit to prejudice, being married to the PHCA Rescue chairman. We are seeing an increasing number of unidentified Pharaoh's in rescue. This of course makes them difficult to trace!



The big Pharaoh Hound activities for the year were clustered around the first weekend of September in New York. At this point in our history the weekend around the Westchester Kennel Club show as the PHCA annual specialty events. This weekend offered four days of shows, the PHCA B-OB Sanctioned Match, Kingston, NY, along with the PHCA meetings and annual banquet.

Back when we were newbies to AKC we still had to meet requirements by hosting the required number of sanctioned A and B matches to obtain full status so we could host PHCA sponsored events. In 1987 PHCA completed the B match requirements and was approved to conduct our first A match, which was held in September 1987.

The weekend in New York was a wonderful opportunity to meet other Pharaoh Hound owners and see old friends. This was a great experience, as the National Specialty events continue to be, but twenty years ago, Pharaoh Hounds were even fewer in number.

In 1987, 34 Pharaoh Hounds completed their AKC CH and six CD's! What's happened to our Pharaohs in the obedience ring? I do not have a complete list of ASFA FCh for the year but records show we had at least six in a report that covered part of the year. There was no AKC coursing at this time.






