#### DIRECTIONS

##### From St. Louis or Springfield, MO

Take I-44 to the Gray Summit exit (Highway 100).  
Go North and follow Hwy 100 until you see Hwy  
MM and the Purina Farms sign (about 0.5 miles).  
Turn left onto Hwy MM. Drive about one mile until

## ELIGIBLE BREEDS and REGISTRY

---

Only purebred Pharaoh Hounds that are one year of age or older may be entered in the regular stakes. All Entries in the regular stakes shall be individually registered with the American Kennel Club (ILP and PAL included), FCI, an ASFA recognized foreign registry or an ASFA board approved registry.

## LURE COURSING TRIAL

---

### REGULAR STAKES OFFERED

**OPEN STAKE:** Open to all eligible Pharaoh Hounds that have obtained an ASFA certification or an AKC Qualified Courser Certificate. Pharaoh Hounds that have earned an ASFA Field Champion title are not eligible to enter the Open Stake.

**FIELD CHAMPION STAKE:** Open to Pharaoh Hounds that have earned their ASFA Field Champion title.

**VETERAN STAKE:** Open to Pharaoh Hounds that are eligible to enter the Open or Field Champion Stakes and have reached 6 years of age on the day of the trial.

**SINGLE STAKE:** Open to Pharaoh Hounds including those disqualified to run in other stakes.

### NON-REGULAR STAKES OFFERED

**KENNEL STAKE:** For two Pharaoh Hounds, designated at the time of entry, entered in one of the regular stakes, owned and kenneled by the same person.

**BREEDER STAKE:** For two Pharaoh Hounds, designated at the time of entry, entered in one of the regular stakes, bred by the same individual.

**BENCH STAKE:** A Pharaoh Hound that is entered in one of the regular stakes and is an AKC, CKC, UKC or ASFA-approved International show champion of record. A copy of the hound's championship certificate must accompany each entry.

## ENTRY INFORMATION

---

1. All entries must be one year of age or older on the day of the trial.
2. First time entries MUST be accompanied by a copy of the dog's registration.
3. Hounds not present at the time of roll call will be scratched after a 5-minute grace period.
4. Each entry will be examined at inspection for breed disqualifications.
5. Bitches in season, hounds with breed disqualifications (except for the Single Stake) and lame hounds will be excused and have their entry fees refunded.
6. Spayed and neutered hounds, without breed disqualifications, may be entered.
7. Monorchid and cryptorchid hounds may be entered.

## OPERATIONAL INFORMATION

---

1. Stake will be split if the entry in any one stake is 20 or more hounds at the time of the draw.
2. All hounds will run twice, in trios, if possible, or braces (except for the Singles Stake) unless excused, dismissed or disqualified.
3. Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
4. Each course will be reversed for the final runs, but the Best of Breed running direction shall be determined by the judge(s).
5. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

## GENERAL INFORMATION

---

1. Please bring your own food, shade and water.
2. A restroom will be available.
3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
4. A \$5 fine will be assessed for loose hounds during courses in progress.
5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
7. PHCA assumes no liability for injury to any person or dog before, during or after the Trial.

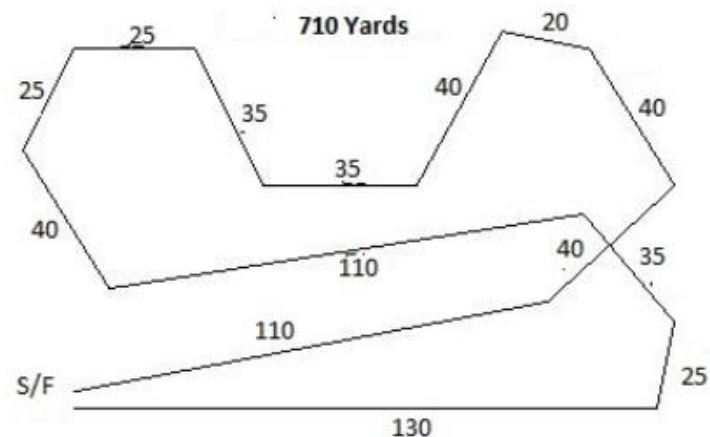
Overnight camping is not permitted at the coursing trial site. However, camping is available at the Purina Show grounds. Refer to the PHCA National Packet for further information.
